

Payment Advice by E-mail – Free-of-Cost Service

As part of our Go-Green initiative, we have started E-mail payment advice service for our merchant partners. To subscribe to this service, please call our Call Centre and get your E-Mail address registered with us. Upon activation, you will start receiving the payment advice daily at your registered email ID (based on your transaction settlements).

With an e-mail advice, you can:

- View merchant identification number-wise transaction details
- View transactional details as per the domestic and international cards
- View the summary of transactions with Gross Amount, MSF Charged and Net Payable Amount along with the Batch Number
- Have instantaneous delivery of payment advice e-mail in your inbox
- Track POS business on a day-to-day basis without requiring to archive paper advices
- Store advices in your mail box or hard drive and access it whenever required
- Print advice when you want to

With effect from July 1, 2008 physical payment advice would be sent on a monthly basis. Should you still wish to receive Physical payment advice daily, you can subscribe for E-Statement Free-of-cost or subscribe to daily / weekly payment advice at a nominal service fee of Rs. 199 and Rs. 99 respectively (plus service tax).

Late Settlement Charges

With effect from July 1, 2008, late settlement charge has been revised to 2% of late settled transaction value subject to a minimum of Rs.10+ Service Tax

Refunds

With effect from July 1, 2008, Merchant Service Fee would be retained by ICICI Bank for all merchant-initiated refund transaction.

Monthly Rentals Fee

Monthly rental fee is being waived if monthly throughput per terminal is more than Rs. 25,000 in a calendar month. If monthly throughput is less than Rs. 15000 it would be Rs. 199 + Service Tax and if the monthly throughput is between Rs. 15000 to Rs. 25000 it would be Rs. 99 + Service Tax.
