

Rs. 50 fuel Preload Offer for Select ICICI Bank Card Customers

Terms and Conditions:

A) Definitions

"Card" shall mean ICICI Bank credit card, which has been issued by ICICI Bank and is valid and subsisting during the Program Period.

"Card Member" shall mean such customer to whom a Card has been issued and who is authorized to hold the Card and who has received the communication from ICICI Bank with respect to the Program by way of sms reminders, an IVR call and an email or through any other mode as per the discretion of ICICI Bank. .

"Eligible Card Member" shall mean ICICI Bank Card Member who is selected by ICICI Bank at its discretion to participate in the Program and has received communication from ICICI Bank confirming that he/she is eligible for the Program.

"Program" or "Rs. 50 fuel Preload Offer" refers to the preload of an amount of Rs. 50 on the Eligible Card Member's Card Account that he can avail on making Fuel Purchase during the Program Period.

"Program Period" shall mean the one-month period which period shall be communicated to the Eligible Card Member in the communication for this Program

"Primary Terms and Conditions" shall mean the terms and conditions applicable to the Card in addition to the terms and conditions for the Program.

"Fuel Purchase" shall mean such purchase of fuel, which shall be made by the Eligible Card Member by swiping the Card on any HPCL Fuel outlet on electronic data capture terminal of ICICI Bank .

All capitalized terms used herein but not defined shall have the same meaning as defined under Primary Terms and Conditions

B) Program

This Program is brought to you by ICICI Bank and is made to the Eligible Card Member unless otherwise notified by ICICI Bank.

Under the Program the Eligible Card Member's Card Account shall receive a credit bonus of Rs. 50. The Eligible Card Member shall be required to use the Card for a fuel Purchase equal to or more than the amount of Rs. 50 during the Program Period.

If there is no fuel Purchase made equal to or more than the amount of Rs. 50 during the Program Period, the Eligible Card Member shall not be entitled to Rs. 50 credit bonus already being given to his / her Card Account and the same shall be subject to reversal/ debit from the Card Account by ICICI Bank at any point of time.

The Program is only applicable on the Card/s that are issued in India.

Eligible Card Member whose Card Account has been classified as delinquent at any time before or during the Program Period shall not be eligible for the benefits provided under the Program. The transaction has to be made on an ICICI Bank terminal only.

C) Other Terms and Conditions

The participation in the Program is entirely voluntary and it is understood, that the participation by the Eligible Card Member shall be deemed to have been made on a voluntary basis.

The participation in the Program shall be deemed to be acceptance of all the terms and conditions governing the Program.

The Program shall not be available on cash withdrawals at ATMs and banks, and personal loans availed by the Eligible Card Member on the Card by using the Card. If the Eligible Card Member ceases to be a Card Member at any time during the Program Period, all the benefits under the Program shall lapse and shall not be available. The Program is not available wherever prohibited

and / or on merchandise / products / services for which such Programs cannot be offered for any reason whatsoever.

All disputes are subject to the exclusive jurisdiction of the competent courts/tribunals of Mumbai.

In all matters relating to the Program, the decision of ICICI Bank shall be final and binding in all respects.
