

## **Terms and Conditions: Spend in the Monsoon Celebration**

### **a. Definitions**

For the purpose of these terms and conditions ("Terms and Conditions"):

- "Cardholder" for the purpose of this Program shall mean a customer to whom a Card has been issued and who is authorized to hold the Card and who has received communication from ICICI Bank with respect to the Program
- "Card" shall mean a credit card, which has been issued by ICICI Bank and is valid and subsisting during the Program Period.
- "Facility" shall mean the condition that the Cardholder should make minimum Retail Purchases worth Rs. 6000/- (six thousand) during the Program Period
- "Gift Offer" shall mean gift of specified item/s to the Cardholder in cases where the Facility is availed during the Program Period.
- Gift" shall mean a wrist watch.
- "Program" shall mean the assured Gift Offer for the Cardholder availing of the Facility during the Program Period.
- "Program Period" shall mean the period commencing from 15<sup>th</sup> June 08 to 15<sup>th</sup> August 08 during which the Facility is availed by the Cardholder.
- "Primary Terms and Conditions" shall mean the terms and conditions applicable to the Card in addition to these Terms and Conditions.
- "Retail Purchase/s" shall mean such purchase, which has been made by the Card holder vide Internet or by swiping the Card on any bank's terminal / POS machine.

### **b. Program / Offer**

- The Program is valid only on Retail Purchases made using the Card. Any cancellations or foreclosures on the Facility before the dispatch of the Gift will amount to cancellation of the Gift Offer to the Cardholder.
- In order to be entitled to receive the Gift, the Cardholder must make minimum Retail Purchases worth Rs. 6000/- (six thousand) during the Program Period.
- A Cardholder will be entitled to only one Gift Offer corresponding to the total amount of the Facility availed of by the Cardholder during the Program Period.
- Gift Offer is non-transferable, non-binding and non-encashable.
- No substitutions or exchange of Gift, other than what is defined herein or detailed in the communication sent to the Cardholder shall be allowed. However, ICICI Bank reserves the right to substitute and/or change the Gift or any of them on account of non-availability of Gift, without any intimation or notice, written or otherwise to the Cardholder.
- All visuals of the Gift in the communication sent to the Cardholder are indicative only.
- The Cardholder/s whose account has been classified as delinquent at any time before or during the currency of the Program shall not be eligible for the benefits of the Program.
- Any cancellations of Retail Purchase/s during the Program Period shall result in cancellation of the entitlement to benefit of the Program. Further, if the Cardholder in any other manner fails to satisfy the basic requisites to be eligible for participation in the Program the same shall result in cancellation of the entitlement to the benefit of the Program.

- ICICI Bank shall not be held liable for any delay or loss that may be caused in delivery of

the Gift.

- In the event any alternative Gift is offered, selection of the same shall be at the sole discretion of ICICI Bank.
- ICICI Bank does not guarantee and make any representation about the quality, usefulness, worthiness and/or character of the Gift, and shall not be responsible if the same are in any way found to be defective.
- ICICI Bank will send the Gift to the Cardholder within 60 days from the closing date of the Program Period.
- Any tax or other liabilities or charges payable to the government or any other statutory authority/body or any participating establishment, which may arise or accrue to the Cardholder due to provision of the Gift, shall be to the sole account of the Cardholder.
