

50% Convenience Charges Terms and Conditions

I. Definitions

- "IRCTC/Alliance Partner" shall mean Indian Railways Catering and Tourism Corporation
- "Agent" shall mean ICICI Bank Ltd (" **ICICI Bank** ").
- "Customer/s" for the purpose of this Offer shall mean Value Banking, Privilege Banking or Wealth Management customers of ICICI Bank who have received communication from ICICI Bank in the form of SMS, notification or e-mail about this Offer.
- "Offer" shall mean such discount(s) /benefit(s) provided by the Agent to Customers on booking rail tickets using Agent's channels/platforms, during the Offer Period.
- "Offer Period" shall mean the period commencing from December 26, 2018 to March 31, 2019, both days inclusive.
- "Convenience fee" shall mean service charges levied by the agent Rs 20 (Twenty) (for non-ac) and Rs 40 (Forty) (for ac) on each ticket booked.

- The customer is required to log in to iMobile app or Internet Banking

- Enter to and from station and make a section
- Enter details of travelers
- Review your fare and see convenience fee at 50% discount
- Pay through ICICI Bank savings/paylater/pockets accounts or credit card.
