

## Cashback offer on booking flight and bus tickets through iMobile app

Get cashback on Flight and Bus ticket booking through iMobile app till April 30<sup>th</sup>, 2019

### I. Definitions

- "TAPZO/Alliance Partner" shall mean One Direct Pvt. Ltd or service provider who has entered into an alliance agreement with ICICI Bank Limited ("ICICI Bank ") for the purpose of providing the Offer.
- "Customer/s" for the purpose of this Offer shall mean value banking, privilege banking or wealth management customers of ICICI Bank who have received communication from ICICI Bank in the form of SMS, notification or e-mail about this Offer.

- The Customer is required to log in to iMobile app
- Select 'Shop'
- Choose 'Flight '
- Continue the booking process
- Apply coupon code on checkout screen
- On successful completion of transaction, customer will get iShop points to redeem the points in next transaction.
