Top 18 Spenders Offer Terms and Conditions:

1. This Offer is valid only for cardholders of the Manchester United Cards, which includes credit cards by "ICICI Bank" Limited and shall be valid from offer period: November 15, 2021, to March 15, 2022.
2. All Cardholders can participate in the Offer provided he/she fulfils all the conditions of eligibility of the Offer during the Offer Period.
3. This Offer is applicable on all Manchester United Cards specified above.
4. The Offer entails the following benefits:
 - The first 18 (eighteen) top spending Cardholders during the Offer Period, shall get an opportunity to watch a Manchester United match at Old Trafford, Manchester, UK inclusive of economy flight tickets (round-trip) and accommodation, which shall take place on May 15, 2022 and shall include:
