

Terms and Conditions for the Bose IE2 Audio Headphones Offer on the ICICI Bank Sapphire Credit Card:

A. Definitions

For the purpose of these terms and conditions ("Terms and Conditions"):

- "Cardholder" shall mean a customer to whom the Facility has been granted by virtue of such customer holding the ICICI Bank Sapphire Credit Card.
- "Card" shall mean the ICICI Bank Sapphire Credit Card, which has been issued by ICICI Bank and is valid and subsisting during the Program Period.
