

Zero Convenience Charges Terms and Conditions

I. Definitions

- "IRCTC/Alliance Partner" shall mean Indian Railways Catering and Tourism Corporation
- "Agent" shall mean ICICI Bank Ltd (" **ICICI Bank** ").
- "Customer/s" for the purpose of this Offer shall mean value banking, privilege banking or wealth banking customers of ICICI Bank who have received communication from ICICI Bank in the form of SMS, notification or email about this Offer.
- "Offer" shall mean such discount(s) /benefit(s) provided by the Agent to Customers on booking rail tickets using agent's channels/platforms, during the Offer Period.
- "Offer Period" shall mean the period commencing from December 6, 2018 to March 31st 2019, both days inclusive.
- "Convenience fee" shall mean service charges levied by the Agent. Rs 20 (Twenty) (for Non-ac) and Rs 40 (Forty) (for ac) on each booked ticket.

- "Ticket" shall mean the rail ticket booking service offered by the Agent.
- "Void Transaction" shall mean any transaction wherein the transaction has taken place but has been cancelled /rejected /unsuccessful by the Agent.
- "Channel" shall mean ICICI Bank iMobile app/Website.

All capitalized terms used but not defined herein shall have the respective meanings prescribed to them in the Primary Terms and Conditions. - All successfully booked tickets will have zero convenience charge automatically levied on the total fare.

- Not valid on Void Transactions.

III. Steps to avail the offer:

- The Customer is required to log in to iMobile app
- Select 'Shop'
- Choose 'Rail'
- Enter to and from and select availability
- Enter details of travellers
- Review your fare and see convenience fee as zero

- Pay through ICICI Bank Account, Credit Card or Pockets app.
