

Terms and Conditions for Current Account Promo

These terms and conditions and the terms ("Terms") apply to and regulate the "Current Account Promo" ("the Program").

1. Definitions

In these Terms, which expression shall include all amendments and modifications made thereto from time to time, the following words and phrases have the meaning set below unless the context indicates otherwise:

1. **"Accounts"** for the purpose of this Program shall mean Retail Current Accounts with ICICI Bank Limited ("ICICI Bank") of all constitutions including individuals, proprietors, partnerships, private limited companies, public limited companies and others.

2. **"Alliance Partner"** shall mean partner who has entered into an alliance agreement with ICICI Bank for purpose of providing the Voucher/Gift.

3. **"Corporate Internet Banking"** shall mean ICICI Bank online platform for Current Account customers.

4. **"iBizz"** shall mean ICICI Bank mobile banking platform for Current Account customers.

5. **"Customer/s"** for the purpose of this Program shall mean a person/ entity/ organization who holds or desires to hold a current account, who has received communication from ICICI Bank by way of direct mailer/ e-mailer/ SMS/ Net Banking or any other mode as per the discretion of ICICI Bank with respect to the Program.

6. **"Gift/s"** shall mean Provogue Watch, Business Wear discount voucher from Trendin.com and IFB Microwave provided by Alliance Partner basis the winner eligibility specified by ICICI Bank herein.

7. **"Online Debit Transactions"** shall mean all customer induced online debit transactions including transactions done through Corporate Internet Banking, transactions done through iBizz, POS (Point of Sale) & online purchases through Debit Card. This will however not include cash withdrawal transactions through ATM.

8. **"Program"** shall mean the Gift provided by the Alliance Partner for using Corporate Internet Banking/ iBizz/ Debit Card during the Program Period.

9. **"Program Period"** shall mean the period from September 1, 2015 to September 30, 2015 both dates inclusive.

10. **"Primary Terms and Conditions"** shall mean the terms and conditions applicable to Current Accounts as available on the site www.icicibank.com and as intimated to the Customer from time to time.

11. **"Week"** shall mean 1-7 September, 8-14 September, 15-21 September and 22-30 September.

2. Program Benefits:

- Accounts using iBizz during the Program Period shall be eligible for Provogue Watch offer.
- Accounts using Corporate Internet Banking during the Program Period shall be eligible for a discount voucher on Business Wear from lifestyle brands on www.trendin.com; additional Rs. 500 flat off on minimum purchase of Rs. 2000 on brands Allen Solly and Van Heusen.
- Customers with highest number of daily Online Debit Transactions shall be eligible for free IFB Microwave in two categories:
 - Companies (private limited and limited companies)
 - All constitution codes other than companies
- Customers with highest number of weekly Online Debit Transactions shall be eligible for free IFB Microwave in two categories:
 - Companies (private limited and limited companies)
 - All constitution codes other than companies
- No Customer shall be eligible for the daily/ weekly highest Online Debit Transactions program more than once during the Program Period. Thus, where a Customer with the highest number of daily/ weekly Online Debit Transactions has been declared the daily/ weekly winner previously during the Program Period, the customer with next highest number of daily/ weekly Online Debit Transactions and who has also not previously been declared the daily/ weekly winner during the Program Period shall be eligible for free IFB Microwave.
- In case there is a draw between customers for the highest number of daily/ weekly Online Debit Transactions, then the winner will be declared as the one having the highest total value of daily/ weekly Online Debit Transactions and shall be eligible for free IFB Microwave.
- Daily winners for IFB Microwave will not be declared on Sundays.
